She organized and taught an inservice course for para-professionals and workshops on Mastery Learn-Marie played the piano for school plays and the Primary chorus. Marie was also building representative for East Islip union activities.

Meanwhile, on the home front, she was helping out with Little League and soccer mom duties as well as helping some of the 56 chil-

She affiliated the East Islip Retiree chapter with Retiree Council 21.

Once a part of RC21, Marie was a founding member of the Benefits

Committee. This is the committee that sponsors the trips, the Welcome Brunch for new Retirees, theater parties and luncheons. At present, Marie is chairperson of the Benevolent Committee. This committee coordinates the Breast Cancer Walk at Jones Beach in October every year, orders and sells Fair Trade products at various meetings and RC21 events throughout the year, and supports and attends activities for ALS.

In addition to RC21 activities Marie has served as an evaluator for the Town of Islip student Achievement Award and has participated in a Women's Health Initiative Extension Study to help advance scientific knowledge about post-menopausal women. Marie also hosts bi-weekly prayer groups through St. Peter's parish as well as providing transportation for those in need and food for shut-

knowledging the leadership of Joan Perini and Tim Wood, he said that the politicos in New York State could count on the input of retirees on their own issues as well as support for all union issues. Even when some supporters loose their initiative, "RC 21 leaders could always be counted on to be front and center with their voices"

Mr. Cameron reminded us that the politicians are after our resources. They can accomplish this by raising benefit payments based on pension income and by cutting benefits themselves. Our pensions are now safe and guaranteed by Article 5 Section 7 of the New York State Constitution which states that our pensions cannot be "diminished" by Only at a Constitutional Convention can this legislation. be changed. WHAT HAVE YOU BEEN MISSING?

Were you there when our members visited the Great Wall of China, rode the new Magnum Train from Shanghai Airport into town – a 22 mile trip in 7 minutes at 250 MPH; or when our group visited the beautiful Amalfi Coast and the spectacular resorts of Sicily; or when we saw Jefferson's home at Monticello, and the beautiful Christmas displays at Longwood Gardens? These trips were offered through the Retiree Council 21 Committees and while they were exciting and interesting, there is more to what RC 21 is all about.

I know you will probably say that meetings are dull and tiresome, and that you don't have the time to attend. What you miss, however, is the opportunity to hear about the latest issues that affect your future. Our programs have included speakers on Medicare, Elder Law, effects of legislation on our pensions and health insurance, and learning what your elected representatives are doing to preserve and protect the benefits you fought so hard to get.

Our meetings are interesting and offer you the opportunity to meet with other retirees and stay connected and involved. There is power in numbers and we need to work together to make certain that our elected union leaders know we are paying attention, lest they forget about us. It pays us to remember that we elect these delegates to NYSUT, and we elect our state and national leaders, and we expect them to support our common purpose and work on our behalf. If we keep our Retiree Council strong in numbers, it will keep our state and national unions strong. Then our elected officials will have to pay more attention to our requests and needs.

It's easy to complain and complaining may make you feel better for the moment. But voting for our informed interests will get us the results that we need. When our elected leaders see us meeting together in increasing numbers, they will have to acknowledge that those numbers will make a difference on Election Day.

A good example of the power we have was the recent protest in June when thousands of NYSUT members and parents assembled in Albany to protest the over-testing of children and demanding the return to time for creative education which our students and teachers deserve. We hope the representatives and legislators were paying attention. This reminded me of the time in 2000 when thousands of teachers protested in Albany to secure a Cost of Living Adjustment (COLA) in our pensions. It may be that we will have to do the same to preserve the COLA in Social Security.

Our hope is that you will consider joining us so that you can enjoy the advantages of being an active member of RC21. A list of our meeting dates and events can be found in this newsletter on page four.

We will welcome new retirees at our October 22 brunch at West Lake Inn in Patchogue. Please join us. You will not regret it.

(from page 1 Awards Luncheon) be aware of our political leaders calling for a convention. The arguments the politicians will give for the advantages of opening the Constitution to "fix" our broken State government can lead us right into their trap of "divide and conquer." This would lead to the weakening of our union's ability to defend the progress we have made in years of fighting for the rights of teachers and all workers. He reminded us that NYSUT represents Nurses, healthcare workers and university teachers as well as public school teachers and lifeguards. We must all stand together to fight the daily attacks on unionism. When the pols are talking about pensions and cuts to Medicaid they are talking about us. Mr. Cameron reminded us that two-thirds of Medicaid money goes to the elderly and disabled in long-term care and nursing homes. Federal level cuts include changing the Cost of Living Allowance to a Chained CPI which lowers the allotment according to consumer price indices.

Vote Cope is the one way we can financially support legislators, in any party, who consistently vote with us on issues brought before the Legislature.

He spoke on Vouchers, the Downstate Hospital situation, Massive Online Learning Classrooms (MOLCS), and the plight of university professors who ,within the last two years, have seen the number of tenure track teachers drop to 31%.

He finished by saying that we are on the minds of the officials of the State because we raise money through Vote Cope and mostly because we have 600,000 voters in New York State. We must use our power by contributing to Vote Cope and especially by voting in local and State elections for candidates who share our goals.

Vote on RC 21 Constitutional Revisions General Membership Meeting - November 19th

Constitutional Revisions approved by the Executive Board on June, 2013*
These changes will be presented at the September 17th General Meeting at West Islip Public Library.

Article V: Participation Fees

B. The participation fees shall be subject to approval by the membership present at a General Membership meeting as designated by the Executive Board.

Article VI: Officers

- B. Duties of the President The President shall add: 9. Establish an annual budget.
- F. In case of failure to fulfill the responsibilities as outlined in **B,C,D,E**, (above), the Officers' position **may be** declared vacant by **majority** vote of the Executive board.
- G. Duties of the Secretary shall: 1. perform *those duties of the office and other such* duties that may be required by the Executive Board.
- H. Duties of the Treasurer The Treasurer shall: 1. *perform the duties of the office and other such duties* that may be required by the Executive Board.
- K. Terms of Office Duly elected officers shall serve a three (3) year term,

Article VII: Delegates to State Affiliate

- C. Delegates shall be elected at the same time and place as officers of RC 21 except by separate ballot, and shall serve a *three (3) year term* to commence on the first of June following the election meeting.
- *Changes are denoted by Bold Italic lettering. Changes were submitted by the Constitutional Committee: Marilyn Gutierrez, Chairperson, and member Peter Leis. The change in terms of office to 3 years was requested by NYSUT to make our elections coincide with their terms of office.
