President Louisa Eiermann



Where to Start....

I have started to write for this newsletter in my head many times. Everytime I read a newspaper or a magazine or a NYSUT or ARA alert or listen to a newscast, the thoughts I believe that are what I want to put down on paper, change. So, I am going to do what works for me and put things in bullet form, not necessarily in order of importance, but that the information in these bullets is something for you to know and think about.

- There will be no COLA for recipients of SS in 2016 due to the low inflation rate.
- Republican presidential hopefuls favor reform in SS, not currently making the privatization for SS a major issue, but talking of raising the retirement age
 and cutting benefits for future retirees.
- The AFT has published an Election 2016: You Decide. Aft.org/election2016. Please read it: you will learn that Jeb Bush advocates for privatization of SS, as does Ted Cruz; Jindal tried to eliminate defined pensions for public employees, Walker slashed state contributions to employee pensions, Paul supports what would be the largest cuts to SS in history, and so on. Rubio, Saunders, Clinton, Biden, Christie, are all there. Did you know that Governor Christie said that that "the nation's teachers' union needs a 'punch in the face' because they are the single most destructive force in public education"? Scott Walker also said "that the minimum wage is really lame".
- The Koch brothers plan to spend a billion dollars on the 2016 Presidential campaign. Vote-Cope raised 9 million last year, and although a significant rise in contributions, the difference in funding is staggering. The brothers hosted a "Defending the Dream" summit in Ohio, inviting 5 candidates as well as wealthy donors and conservative activists. The Ohio AFL-CIO

organized a rally of protest. Whose dream are the brothers defending?

- You can have Vote-Cope donation deducted from your pension. If you already do this, you can increase your contribution. Forms for this will be available at our fall brunch.
- Mario Cilento, president of the NYS AFL-CIO, had a letter published in the Buffalo News: Unions are the voice for middle-class workers. He says that "while the labor movement has made tremendous strides (union membership is at its highest level in 7 years), the attacks by our opponents are relentless".
- On September 10th, in the NY Times, a study was released, page A20, establishing "that children born to low-income families typically ascend to higher incomes in metropolitan areas where union membership is higher."
- Headline: Low-Income Workers See the Biggest Drop in Paychecks". Don't believe it? Go online to the NY Times Business Section, Thursday September 3rd.
- The U.S. Supreme Court is hearing the case of "Friedrichs vs. California Teachers Association". Friedrichs is challenging the requirement that teachers contribute to unions. The loss of this case would put an incredible financial strain on unions across the country. With a Friedrichs win, retirees having to pay dues could be on the table.
- We do NOT want a Constitutional Convention on 2017. However, 69% of those polled said they favored having one. You do not need to have a Constitutional Convention to make changes. You can have amendments. Our current Constitution guarantees everyone the right to a free public education, the right to

unionize, the care of our public benefits and so on. • Which one of these are we willing to forfeit?

- One must be registered to vote by this October 9th, 2015 in order to vote in the 2016 primary.
- The Friday, September 4th, Newsday headline, read "Cuomo: Time to Fix the Common Core." No comment. Read it and be amazed.
- In the July/August NYSUT United magazine commissioner Elia "pledged to listen to educators and parents. "The reason that kids will be successful in school is because of the teachers, " Elia told reporters. "And we need to make sure they have all the support they need." In Newsday's September 3rd edition, she told reporters she had no authority to change state law. As the article points out she "does have the ability to push for change in those laws…" Will she?
- Thomas Sobol, the NYS education commissioner for 8 years, died on Thursday, September 3rd. In his obituary, Diane Ravitch wrote: Tom Sobol was the last state commissioner who understood that education means something more than test-taking and high scores." Read the obituary in the September 5th, NY Times. It tells an interesting story of him and our state.
- President Johnson signed Medicare into law on July 30th, 1965. It just had its 50th Birthday! As of 2014, 54 million people were on Medicare. Where would retirees be without it?

- As of this writing, Seattle teachers are on strike, for the first time in 30 years, as are those in PASCO, Washington, and Scranton teachers are getting ready to also possibly strike, to name a few places where our colleagues are in stress. Ask your own in-service locals how they are doing.
- Last week the highest court in Washington State said that "much of the law underpinning the new charter school system was unconstitutional. " Maybe this harkens a new trend in deciding that public school funds should stay with our traditional public schools.
- Join the Member Action Center, the MAC, now. Text NYSUT to the contact number 38470. Every Tuesday or whenever necessary you will receive an alert from NYSUT on your cell phone.

There is more, of course. Every day the amount of information that is out there is incredible. When there are people who think we are the enemy, teachers and retirees, we have to speak out, be a voice, armed with knowledge. Read and question. There is so much at stake for us as retirees, for our in-service colleagues, for our children and grandchildren. Be proud of who you are and what you have accomplished.

Finally, the youngest winner of the Nobel Peace prize, Malala Yousafzai, the Pakistani student who was shot by the Taliban for defending a girl's right to education, wrote: "Let us remember: One book, one pen, one child and one teacher can change the world." You really can.
