A Message From

President Joan Perrini



We Are The People Who Gave You the Weekend

Current public opinion of teaching and teacher unions has reached a critical point in this country, and in particular New York State where we live. I am continually amazed at the reaction of some people when asked what they think of teachers. Sadly, most of them respond that they love the teachers in their school district, but they don't like the teacher unions who create all kinds of problems. To some of you this may seem like just another issue that will go away if we don't think about it, because you're not sure what you can do and you may think "What can I do about it anyway."

Well, I believe we all have to care about it and we have to act soon. Collective bargaining in public schools could change and that would mean disaster. We cannot afford to ignore it anymore.

Many of you will remember how it was when you taught back in the 1960s when teacher salaries were very low and good working conditions non-existent. Jokes were often made about the plight of the "poor" teacher and few people desired to enter the field of education. But you and I dared to be teachers because we wanted to make a difference. A few months ago I wrote about the struggle we faced then, the rewards we realized in the end, how our status of teaching was raised and our salaries and benefits started to match those of other respected professions.

But now the economy in our country is so bad that everyone is looking for someone or something to blame. Profitability of US corporations, as a share of our total gross domestic product, has never been higher; the reason is that all of the benefits of productivity have gone into profits instead of sharing it with the workers. Management even refuses to raise the minimum wage which would give workers the financial help they so badly need. The weakening of unions has caused the decline of the middle class because wages have not gone up in 40 years, adjusted for inflation. The benefits of the increased productivity in this State and this country have gone to the 1% and zero has gone to the worker.

People have forgotten why unions had to be created in the first place. Made up of workers for the protection of workers, when these unions were established they helped to create a middle class which improved the economy and kept a balance of power against greedy corporations.

This philosophy has now spilled over to the field of education and again we have people playing the blame game naming teachers, their benefits and, in particular, their unions as the cause for everything that may be wrong with education. My friends, there is much at stake if this continues.

So to help us respond to the naysayers and critics, here is some ammunition to use when your friends and neighbors complain about teachers and their benefits.

Our critics have complained about the defined benefit pension as being too expensive and that we should switch to defined contribution pensions (401K and 403B). The unions have protected defined benefits pensions and it has been proven that they work far better than defined contribution pensions, are less expensive and provide a safeguard against poverty in old age. In addition, New York pensions have a history of being very well managed thanks to our Comptroller, Tom DiNapoli.

While some people do think that pensions are an unnecessary expense of public employers, we should remind them that 85% of the money that is given out in pensions in New York remains in New York and contributes to the economy of New York. Any businessmen who complain that our public pensions are costing too much, forgets that the middle class is spending this money in their communities and on their businesses.

Beyond pensions, let us not forget that teacher unions have worked for security in schools, better conditions for teachers and students, educational advancement and have kept a balance between teachers and management. I saw a bumper sticker recently that said "WE ARE THE UNIONS – THE PEOPLE WHO GAVE YOU THE WEEKEND." What a contrast to the old statement of management that said "IF YOU DON'T COME IN SUNDAY, DON'T COME IN MONDAY."

So when the public says that they love teachers, they cannot say that they hate the union, because they are one and the same. We have good schools in *(continued on page 3)*
