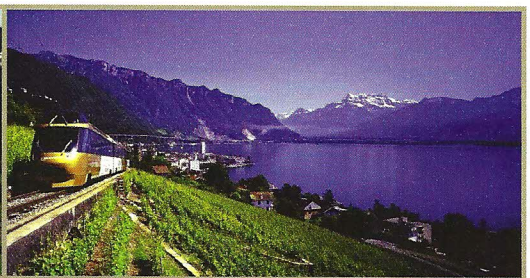
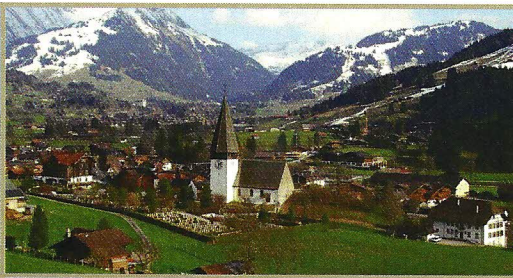

### Day 1: Overnight Flight

Depart on your overnight flight to Europe to begin your tour.

### Day 2: Arrive in Switzerland

In these villages, the "Lavaux" wine growers live and press their own grapes. Visit a local wine cellar to sample & taste the wines of the region. This evening dinner is included at a popular local restaurant.

### Day 4: Zermatt

Depart Montreux and travel through the impressive **Rhone Valley** highlighting orchards and vineyards. Arrive in Tasch to board a **Cogwheel Railway** for the short trip to the famous car-free Alpine resort of **Zermatt**. Zermatt is situated at the foot of the majestic **Matterhorn**, one of the world's most famous mountain peaks. Enjoy free time to explore Zermatt on your own. Maybe on your own ride up to the Gornergrat (weather permitting--10,130 ft above sea level) offering incredible views of the Matterhorn and 29 of the highest peaks in Europe.

### Day 5: Bern - Interlaken

Today visit **Bern**, the beautiful capital city of Switzerland featuring cobblestone streets under medieval arches making it one of Europe's most picturesque cities & registered as a UNESCO historic site. Enjoy a **Bern City Tour** to see the famous **Bear Pits**, the **House of Parliament**, the **Rose Garden** and the impressive **Cathedral**. Enjoy time at leisure in Bern's Old Town dining, exploring, strolling and/or shopping.

This afternoon stop in **Interlaken**, a charming town situated between Brienz & Thun Lakes and surrounded by incredible mountain scenery. Return to Montreux for an evening at leisure.

### Day 6: Golden Pass Train to Gstaad & Gruyeres

This morning board the **Golden Pass Train** and travel from Montreux to Gstaad. Sit back, relax and enjoy the panoramic mountain scenery enroute to the small resort village of **Gstaad**. Later board a motorcoach and travel to **Gruyeres**, a charming hilltop town famous for a 12th century castle. Gruyeres is an unspoiled, car-free medieval village with lovely houses along cobblestone streets. Next visit a **Swiss Cheese Dairy** where you can see cheese being made and taste the finished product.

### Day 7: Chamonix

Today travel to France and visit the beautiful ski resort of **Chamonix**, home of the first Winter Olympics in 1924 and situated at the foot of Mont-Blanc, the highest peak in Europe. Then travel via the Great St. Bernard Tunnel and return to Montreux. Tonight enjoy dinner with your fellow travelers.

### Day 8: Montreux - Aosta - Como

Today travel from Switzerland to Italy. Visit the medieval town of **Aosta**, the first town south of the Alps before arriving in **Como**. Enjoy a panoramic tour of the Como area before you arrive at your hotel. Enjoy dinner tonight with your fellow travelers.
