What Are You Willing To Give Up?

The Constitution of New York State provides for the protection of those rights that have been determined, by history and over time, to belong to the citizens of the Empire State. On November 7, 2017 we are required to vote on a referendum that will ask the question: "Do we need a Constitutional Convention or not?" (NOTE: It will be the first question on the reverse side of the ballot.)

This question is placed on the November ballot every twenty years in accordance with the Constitution itself (article 19). In the event that extraordinary problems might develop not addressed in the Constitution this requirement would allow for a convention to address such serious issues. Conversely, this requirement also allows for the citizens of New York to vote "No!" as an indication that a convention is not needed.

Such a convention, at first glance, could offer the opportunity to update the language, modernizing phrases of the Constitution's article. However, like any contract, once the door is open every word, phrase, sentence, paragraph, and article of the Constitution is open to scrutiny, alteration and/or amendment. This scenario would dangerously allow special interest groups access to changing fundamental rights guaranteed to the citizens of New York. Democracy is based on the intellectual debate of ideas and the resulting compromise of both sides of that debate. In the confines of a convention, such a democratic process would, by compromise, put many of our rights in jeopardy. Any compromise would necessitate that an atmosphere of quid pro quo exist, something that you hold dear must be given up in order to keep what is important. What are you willing to give up?

Many of our protected rights are under attack, which of these are you willing to give up? Are you willing to alter the right of a child to a free public education? Are you willing to allow the legislature to reduce a retired public employee's pension? Are you willing to reduce the benefits provided by worker's compensation laws? Are you willing to allow a worker's right to organize, a union's right to charge an agency fee, and the entire process of collective bargaining to be curtailed or taken away? Are you willing to put the lives of those less fortunate at risk by altering the safety net provided by social service laws? Are you willing to eliminate the Blaine Amendment that prohibits the expenditure of public funds for use in religious schools? Are you willing to change the necessity of legislative input into the state budget? Are you willing to open up the Adirondack Park to commercial development? Are you willing to allow the state forests and parklands to be harvested for their natural resources?

REMEMBER: The state legislature has the power to propose changes/amendments without holding an expensive convention. These changes must be put before the voters for approval. This process has been used to amend the NYS Constitution 200 times since 1894.
